- 1. These regulations (hereinafter: "**Regulations**") define the rules for accepting donations by the Foundation Intelligent Technologies.
- 2. Foundation Intelligent Technologies, with its registered office in Sękocin Nowy (05-090) at Al. Krakowska 61A, entered into the register of associations, other social and professional organizations, foundations and public healthcare institutions of the National Court Register maintained by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Department, under KRS number 0000567814, NIP: 5223034228, REGON: 362095247 (hereinafter referred to as the "Foundation" ") may accept donations from natural persons, legal entities and other entities without legal personality.
- 3. Accepting donations is continuous.
- 4. Donations to the Foundation may be made in the form of payments of financial resources and in kind.
- 5. All donations and gifts in kind are voluntary and constitute a donation within the meaning of Article 888 et seq. of the Civil Code.
- 6. Donations made are non-refundable.

§ 2

- 1. Donations in the form of cash can be made by bank transfer made to the appropriate bank account of the Foundation or through online payments.
- 2. Confirmation of acceptance of the donation in the form of financial resources is a printout of the transfer confirmation.

§ 3

- 1. Members of the Foundation's Management Board are authorized to receive a donation in kind.
- 2. The willingness to make an in-kind donation to the Foundation should be reported in writing (also in the form of an e-mail) or by phone in accordance with the contact details provided on the Foundation's website.
- 3. The donor is obliged to provide the value of the transferred items. If the donor does not provide a value, it is determined by the person authorized to receive the donation.
- 4. The donation and acceptance by the Foundation should be confirmed by the protocol of accepting the donation in kind.

§ 4

- 1. The donations made will be used for the statutory activities of the Foundation.
- 2. The Foundation has the right to refuse to accept the donation.

- 1. The administrator of the Donors' personal data is the Foundation Intelligent Technologies, with its registered office in Sękocin Nowy (05-090) at Al. Krakowska 61A.
- 2. The Donor may contact the Administrator by writing to the following address: Foundation Intelligent Technologies, Sękocin Nowy (05-090), Al. Krakowska 61A, writing to the e-mail address: kontakt@fundacjait.org or by calling the following number: +48 22 379 87 00.
- 3. By donating, the Donor accepts these Regulations and agrees to the processing of his personal data by the Data Administrator.
- 4. The donor provides personal data voluntarily and declares that they are truthful.
- 5. The legal basis for the processing of Donor's data is consent, which is granted because of donating and for the acceptance of which the processing of donor's data is necessary.
- 6. Donor's personal data are processed only for purposes related to the acceptance and accounting settlement of the donation.
- 7. Providing personal data is not mandatory, however, failure to provide them will make it impossible to donate.
- 8. Donor's data will be stored no longer than it is necessary, i.e., by the one necessary to accept and settle the accounting of the donation made.
- 9. The Donor has the right to request from the Administrator access to their data, rectification, transfer and deletion, as well as the right to limit the processing of data.
- 10. In connection with the processing of the donor's personal data by the Administrator, the donor has the right to lodge a complaint with the supervisory body.

§ 6

- 1. These Regulations are effective from 15.02.2022.
- 2. Any changes to these regulations require a written form under pain of nullity.
- 3. Any changes to the Regulations may be made only by the Management Board of the Foundation.
- 4. To matters not covered by these Regulations, the generally applicable provisions of Polish law shall apply.
